1.0 Purpose

The Coordinator works collaboratively with the Senior Manager: Kindergartens and Care to provide support, service, and leadership to the Kindergarten and Care services across the Diocese.

The support provided by the role holder will be guided by

- other Catholic Church teachings, principles, and values
- relevant legislation, government requirements, and best practice
- Diocesan Strategic Plan, mission, vision, policies, frameworks, procedures and guidelines
- the Kindergartens and Care Services strategy.

2.0 Experience and qualifications

Essential

- Diploma in Children Services or equivalent
- Certificates in First Aid, CPR, Asthma, and Anaphylaxis
- a current blue card for working with children issued by Blue Card Services, or a willingness and ability to obtain one
- a thorough understanding of the Education and Care Services National Law Act 2010 and Educational and Care Services National Regulations 2011
- conversance with National Quality Framework and My Time Our Place
- conversance with relevant regulatory authorities
- experience with QikKids and Storypark
- willingness to be the Nominated Supervisor of the service
- demonstrated ability to set priorities and monitor workflow
- demonstrated high levels of problem solving, decision making and negotiation skills
- use of discretion and judgement
- ability to provide leadership of others in the use and interpretation of localised policies, procedures and guidelines
- effective relationship building and influencing skills



- demonstrated experience working with the Microsoft suite of products
- advanced interpersonal and communication skills
- empathy with the values and ethos of the Catholic faith

Desirable

- a minimum of 2 years of experience in education and care of children
- leadership of a childcare service

4.0 Statement of responsibility

- 4.1 The incumbent performs the role cognisant of and in harmony with the vision and mission of TCKC.
- 4.2 The incumbent will work cooperatively with other key stakeholders both within TCKC, TCSO, and external agencies to ensure that services are delivered in a planned, coordinated, and strategic manner.
- 4.3 The role holder will engage in performance reviews in accordance with TCKC policy and procedure.
- 4.4 While at work the role holder must
 - take reasonable care for his or her own health and safety
 - take reasonable care that his or her acts or omissions do not adversely affect the health and safety of other persons
 - comply, so far as the role holder is reasonably able, with any reasonable instruction that is given by the person conducting the business or undertaking to allow the person to comply with the Work Health and Safety Act
 - cooperate with any reasonable policy or procedure of the person conducting the business or undertaking relating to health or safety at the workplace that has been notified to workers.

5.0 Authority limits

Full authority is delegated from the Executive Director: Catholic Schools to produce the desired outcomes. Authority to commit funds is restricted to approved budget items and can only be authorised by the Senior Manager: Kindergartens and Care or the Executive Director: Catholic Schools.

The Coordinator reports directly to the Senior Manager: Kindergartens and Care. Other significant relationships exist with members of the Toowoomba Catholic Schools Office and the members of the Executive Leadership Team (ELT).
